With financing through Affirm, you can break down the cost of all or part of your tuition fees into monthly instalments.

For approved candidates, payment plans start at 0% interest and can be spread over 24 months. Note that APRs, loan amounts, and repayment periods are dependant on approval.

RESP & RRSP

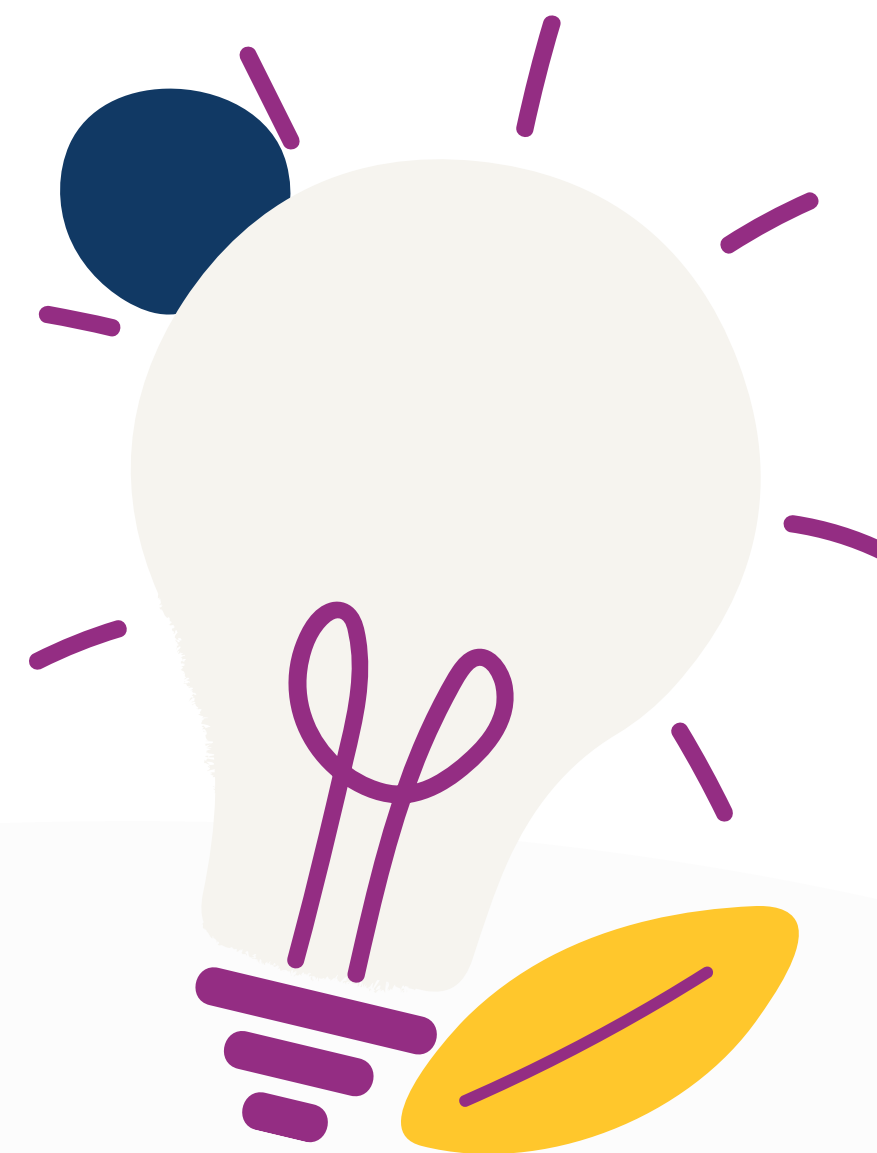
You can withdraw from your [RESP](#) or your RRSP through the [Lifelong Learning Plan \(LLP\)](#).
